

# **Draft Nelson Square Concept Plan Consultation Summary Report**

Submission Summary

19 January 2023 – 9 February 2023

## **Project Overview**

City of Port Lincoln invited the community to give feedback on the new design concept for the enhancement of Nelson Square from Thursday 19 January 2023 to 4pm on Thursday 9 February 2023.

Previous community consultation was conducted on the Nelson Square Dog Park Concept from 16 September 2021 to 7 October 2021. Throughout the consultation, feedback was generally supportive of the concept as designed, however there were objections raised, some in opposition to the potential sale of land and some in significant opposition to the dog park concept itself being located at the reserve. As a result of community consultation and feedback Council determined at the Ordinary Council meeting held on Monday 18 October 2021 to pause any further decision until an alternative layout plan had been developed for the entire Nelson Square reserve that did not include a dog park.

Council engaged local company E+MQ Architect and Landscape Interior Design to come up with a concept to enhance the amenity of the reserve taking into consideration previous feedback on what the community would like to see for the community reserve.

The proposed upgrades at Nelson Square will be fully funded through the Federal Government's Local Roads and Community Infrastructure Program. The \$250,000 will go towards revitalising the much needed and loved community reserve.

The concept for Nelson Square has been designed around accessibility, protecting the native Flora and Fauna and creating a space for families to gather, relax and play.

The enhancements will include refurbishment of the old Tennis Court Clubrooms into an accessible/unisex toilet and new shelter / BBQ area and seating. The old tennis courts will be upgraded to a multifunctional sports space for playing tennis including netball and basketball with the inclusion of netball and basketball rings.

The existing playground will be removed, and new play equipment installed, including featuring repurposed equipment from the foreshore playground. Internal footpaths will link the areas of the reserve suitable for wheelchairs, prams, small scooters and kids on bikes to move through the reserve.

The existing parking area on Volante Street will be formalised and the internal parking area and access track will be resurfaced. The Oleander scrubs and Aleppo Pines will be removed to protect the native vegetation and replaced with Australian natives throughout. Additional new plantings, irrigated turf area and revegetation of some areas will be undertaken.

These upgrades to Nelson Square are part of Council's commitment in the Open Space Strategy 2021-2026 to deliver new and upgraded open spaces over the next four years. These enhancements to Nelson Square are planned to be completed by 30 June 2023.

1	Nelson Square Upgrade	Hi I like your proposal for the Nelson Square Upgrade. My feedback to your plan would be to expand the grassy area labelled 2 to also include section 3. I don't think this change would alter costs to be substantially more than revegetation of the zone. I think expanding the irrigated grassy area into section 3 would be the most advantageous use of this space. Advantages include- Greater area for families to use for recreation with the protection of the surrounding established trees. It gives more space for those waiting to use the tennis courts, greater space for lawn sport activities (boche etc), greater space group picnics and blankets, greater space for exercise groups to utilise. Increasing the grassy space may open the opportunity for it to be used ( with council permission) for jumping castle etc for parties. Given the large areas of vegetation surrounding the square and in zones 9,8, I feel having this area become a revegetation zone would be a waste of very usable space.

		the bush, onto a road or away from the playground whilst a parent is tending to

If it needs re-furbishing, re-furbish and leave it on Tasman Terrace. 6. Do no remove cement border of existing playground area. It has a role in preventing erosion as evidenced by the difference in soil levels on either side of it 7.Do not remove concrete installation that was the practice cricket pitch. Repair the minor cracks and paint with, for example, a hopscotch outline. 8. Do not remove large old Aleppo pine adjacent to amenities block. Important shade and is used by children currently. #### **Issues: Nelson Square compared with Parnkalla Trail**

- 1. Please note that I do support up-grading facilities at Nelson Square but it seems unethical (immoral) to be spending \$200,000 (or thereabouts) on Nelson Square that is under-utilised (and will continue to be under-utilised) compared with Parnkalla Trail that has had almost no money spent on it except for the grant obtained by and the chair funded by There is a committed Friends of Parkalla Walking Trail but there is no equivalent group who care for and help to maintain Nelson Square hence the feeling shared by many that Parnkalla Walking Trail is being ignored by Port Lincoln City Council. Savings can easily be made to the proposed concept and are outlined below.
- 2. Related to the above, rate payers may find it unacceptable to have the refurbished playground equipment from Tasman Terrace re-located to Nelson Square given:
  - i) in the Survey Monkey 'Have your say' about the foreshore development proposal. 69% objected to aspects of the redevelopment proposal. Of these, 13% (= second highest objection) did not want the playground removed; and,
  - ii) a total of 1339 signatures were submitted to Council (24 June, 2021) in an objection to the proposed removal of the Tasman Terrace playground. This is a significant proportion of rate payers in Port Lincoln.

### Nelson Square Upgrade savings that could be channelled to Parnkalla Trail

- 1. Do not remove existing playground equipment in the Square. It has historic value and is used daily.
- Do not fence playground area. On Tasman Terrace it would be imperative because of the traffic but this is unnecessary in Nelson Square and has never been considered necessary. Maintain bollards and improve this barrier if it is deemed necessary.
- 3. Do not remove old Nelson Square playground sign historic value.
- 4. Do no remove cement border of existing playground area. They assist in erosion control as is evidenced by the differing soil levels on each side of the border.
- 5. Do not remove concrete installations where surface is still intact. Repair the cracks and paint with, for example, a hopscotch grid.
- 6. Do not remove old Aleppo pine adjacent to amenities block. It provides important and natural shade and is used by children currently.

- 7. Do not put paving as proposed. Use path surface similar to that on Parnkalla Trail. The path needs to be in-keeping with the 'bush' feel of the square not reflect a sterile suburban environment.
- 8. Ensure that 'feature trees' chosen will grow easily in this climate and the soil type at Nelson Square and will not require watering beyond the first two summers. Preferable plant natives in keeping with the natural vegetation already covering the majority of the Square.
- 9. Consider having some surface other than irrigated lawn. This will attract a large on-going bill, water is in short supply and savings could be channelled to the Trail.
- 10. Friends of Parnkalla Walking Trail are prepared to undertake to remove young Aleppo Pines,

  Rhamnus and Polygala all of which need to be removed. They are also prepared to repair the 2 cracks in the cricket 'slab' and paint a hop-scotch (or other) outline there.

#### Nelson Square

Please retain all existing native vegetation, do not prune or open up understorey as this makes trees prone to insect attack and premature death. This park has some great remnant vegetation that is perfect habitat to the small insect eating birds.

Please encourage a "friends group" to help with management of freesia's and invasive species and garden escapes.

The tennis court and barbeque area refurbishment will make it more appealing for families, and making it multipurpose with basket ball rings etc will give it wider function. While I am in favour of a grass play space, I hope this can be irrigated by storm water captured on-site or reclaimed from the on-site toilet facilities. Installation of a bio-cycle type system could be a great education and demonstration opportunity to encourage better appreciation of water as a valuable resource and show Council is willing to lead by example. Area 3 – the revegetation area could include some 'nature play' logs and paths through raised or mounded beds with local wildflower and different textured plantings. Kings Park in Perth has some amazing examples of dry creek beds, log stepping stones, borders and natural seating. Maybe made from some of the felled pines?

Agree the oleanders should go, but please ensure the replacement native hedge type of species has established to act as a functional windbreak, like the existing trees do.

The slopes across the site mean that hard surfaces need to be very carefully planned so they do not increase the erosion problems. Beds of vegetation regularly across slopes may help to slow water flow and encourage it to soak in rather than run over it.

The pine trees currently provide great shade because so tall – maybe retain some strategic ones for now until some very tall gums are able to replace the quality of shade that is presently provided.

Retain existing play equipment (and sand) and supplement with items relocated from the foreshore – please do not fence everything though. The traffic risk in this area is minimal and fencing stifles imaginative play.

Improvements to car parks is welcome, but once again try to retain as gravel or dirt that allows rain to penetrate – the concept of utilizing thick rope to delineate individual parking is favoured over hard-sealing and painted lines. Careful attention to run-off and erosion are needed for the internal parking area, whether this is using subtle contour banks to slow water flow and direct run-off gently to deep-rooted mallee and sheoak areas.
