Submission Draft ABP & Budget 2023/2024	The amount of funding budgeted for paving of existing unpaved footpaths in the residential streets of Port Lincoln is inadequate. Many residential streets still have no paved footpaths at all, while many others have a paved footpath on just one side of the street. Many of the unpaved footpaths in the residential streets of Port Lincoln are unsafe on which to walk, let alone to push a baby carriage or to ride a personal mobility vehicle, and yet the council does very little or nothing to remedy this situation by making an effort to progressively upgrade and pave all these substandard and unsafe footpaths. submission	Mayor Diana Mislov City of Port Lincoln Your Worship Thank you for suggesting I make a written budget submission to Council relative to the Town Jetty. A substantial financial savings exists from shortening the Town Jetty. From Bent 31 the seaward jetty length is approximately 45 meters. This length represents about 20% of the total jetty. Council should request from Maritime Construction Ltd a comparison of: 1/ An estimate of repairs/ replacement from bent 31 seawards to the existing end of the jetty. 2/ an estimate of cost to remove the jetty from bent 31 onwards. The savings of not having to repair and replace some 45 meters of jetty piles, structural timbers, hand rails, etc will be significant. Irrespective of the above cost saving, there is the practical reality that it is impossible to correctly protect the swimming pool by retaining the existing jetty length. All repairs or replacement seaward of bent 31 is fundamentally stupid. Council should consider the criticism of the Essential Services Commission, [times, 11th may, page 3] where it states average rate rises of 3.4% annually for the next 9 years may cause community difficulties:And Council wants a 9.5% rise this year alone!
