# **REPORT DETAIL**

# **Background**

At its meeting on 21 October 2024, Council resolved to seek public comment on the proposal by Greg Nicholls to obtain a business use of road permit, to enable closure of one car park on Tasman Terrace, in order to construct an outdoor dining area adjacent to 80-81 Tasman Terrace. The proposal is associated with the development submission received for a change in use of the existing building at 80-81 Tasman Terrace to a shop (restaurant).

CO 24/198 Moved: Councillor Broadfoot Seconded: Councillor Cowley

That pursuant to Local Government Act 1999, Section 223, Council seeks public comment on the proposal by Greg Nicholls to obtain a business use of road permit, to enable closure of one carpark on Tasman Terrace, in order to construct an outdoor dining area adjacent to 80-81 Tasman Terrace.

**CARRIED** 

Council proceeded with the community consultation and the consultation was open from Thursday 24 October 2024 to Friday 15 November 2024, with the community invited to provide feedback on the proposal. The opportunity to provide feedback was advertised via social media, media release, local radio, a public notice in the Port Lincoln Times, letter drop to surrounding businesses, Your Say page on Council's website and Council e-newsletter.

The engagement activities conducted resulted in Council receiving 18 submissions which have been collated in Attachment 1 (DOC 55640), Business Use of Road Permit 80-81 Tasman Terrace consultation submissions received.

# Feedback Summary

Of the 18 submissions received, a clear majority of twelve (12) submissions expressed opposition to the proposed Business Use of Road Permit, 3 submissions were in favour, and 3 submissions were neutral or would be supportive if improvements were made to the existing crossing.

Of those opposed to the proposal, concerns raised included:

- Impact to parking availability with loss of a car parking, together with the potential increase in patrons considered detrimental to existing businesses, visitors, and residents;
- Further impact to footpath users with a through-path that may be more congested with people standing and talking to those sitting down, prams, dogs, shelters etc.;

 Need for improved crossing point for pedestrian safety, especially with an increase in patrons in the area.

Those in favour of the proposal cited the benefits of:

- An expanding business; and
- Having more space for outdoor eating options near the foreshore.

Other submissions requested improvements associated with the proposal, such as including the need for an improved pedestrian crossing across Tasman Terrace and maintaining the footpath in a straight line along the edge of the buildings and under the shelter from the rain, unlike some other outdoor eating areas where the public have to walk around.

There were also several comments made about having an additional restaurant in the area, which is a separate standard town planning and development decision, that has been made for a change in use of the building.

# **Audit and Risk Committee Question with Notice**

In addition to the submissions received, a Question with Notice was made by Independent Member of the City of Port Lincoln Audit and Risk Committee, Greg Eden at the Audit and Risk Committee meeting held on 6 November 2024. An extract of the minutes of the question with notice and response has been included below:

# <u>QUESTION WITH NOTICE – MR GREG EDEN - BUSINESS USE OF ROAD PERMIT 80-81 TASMAN</u> TCE

Independent Audit and Risk Committee Member Greg Eden raised a query in the meeting regarding the current community consultation process underway with respect to a Proposed Business Use of a Road Permit for 80-81 Tasman Terrace, with specific reference to pedestrian safety within this vicinity.

Mr Eden requested that this issue be added to the Audit and Risk Committee Agenda for the next Audit and Risk Committee meeting.

#### Response:

Council has received a request for the use of a portion of road related area at 80-81 Tasman Terrace for business purposes as part of a development application for the tenancy immediately adjacent this segment of road reserve. The request was made under Section 222 of the Local Government Act 1999, which deals with business use of a road related area, and due to the restriction of use of this portion by the broader community, requires public consultation under the Act.

Council has considered the application and has resolved to put the matter out to consultation as required. As part of this process, Council has received feedback indicating pedestrian safety as a concern. Upon completion of the public consultation process, when considering the feedback, Council will also complete a technical assessment of the pedestrian safety concerns raised and will consider:

- 1) Whether the application can be approved in its current form;
- 2) Whether further works need to be mandated to ensure pedestrian/patron safety;
- 3) Whether other works are required in an alternate location to allow for pedestrian safety;
- 4) Any other matters.

Therefore, Council administration is aware of the risk identified and will complete a technical

Therefore, Council administration is aware of the risk identified and will complete a technical assessment of the proposal once the public consultation period concludes. This assessment may result in the application not being approved or approved with conditions.

#### **Technical Assessment**

A technical review of the provision of an improved pedestrian crossing point on Tasman Terrace was undertaken by Council Traffic Engineer, Frank Sow in 2010. The review highlighted that should a formal crossing be required then a WOMBAT crossing similar to that in front of the Nautilus Theatre could be considered.

However, there are conditions (Refer DIT – Supplement to AS 1742.10, Manual of uniform traffic control devices, Part 10: Pedestrian control and protection, Appendix B2) required to be met prior to consideration of such a crossing such as;

A pedestrian survey undertaken shows that:


- a) In two separate one-hour periods of any day (including Saturday and Sunday):
  - 40 or more pedestrians per hour actually cross the road and could reasonably be expected to use the crossing; and
  - 200 or more vehicles per hour pass the site where the pedestrians cross during the same two hours; or
- b) During eight hours of any day:
  - An average of 20 or more pedestrians per hour, cross the road (a total of 160 or more in eight hours) and could be reasonably be expected to use the crossing; and
  - An average of 200 or more vehicles per hour pass the site during the same eight hours (a total of 1,600 or more in eight hours)

Since the 2010 review, the layout of Council's foreshore has changed with the creation of the new play space opposite the Nautilus Arts Centre and the previous playground space opposite Del Giornio's Restaurant being converted into an activity plaza containing half-court basketball. These changes have resulted in pedestrian traffic generation and movements being modified and hence a current pedestrian survey should be undertaken to determine the pedestrian activity and numbers still present at the current informal crossing point.

It is also worth noting that, while the breeze-way/arcade adjacent Del Giorno's provides a north-south pedestrian link to carparking and shops to the south of the subject site, other potential crossings have been identified by consultants, on either the east or west side of Del Giorno's, to enable public walkway connectivity with existing pathway's that link through to Washington Street.

The Port Lincoln Precincts Master Plan (Jensen Plus, September 2020: p.43) identifies such a north-south crossing/link should be located between the current Government Building (73-75 Tasman Tce) and the ANZ bank (76-77 Tasman Tce) some 45m further west of the existing informal crossing point.

Please refer to the below image detailing this above described 2020 north -south walkway option, it is the second from the left, and proposes to utilise the axis of the ANZ bank driveway for mixed pedestrian movement:



The technical review completed in 2010 identified that a more formal pedestrian crossing would result in the loss of up to 7 car parks, refer sketch concept plan below, this remains the case today. Many of the objections received were based on not accepting the loss of any additional car parking spaces which would be at odds with the creation of a formal crossing point.

It is estimated that an 8–12 hour traffic and pedestrian survey and subsequent report on preferred crossing point location and concept layouts would be in the order of \$15,000 - \$20,000.




Figure 1 - Concept Layout for Wombat Crossing - Tasman Terrace

# Recommendation

Section 222 of the Local Government Act 1999 provides for authorisation and permits to allow people to occupy for exclusive occupation or otherwise occupy portions of public road reserves.

Following consultation from the public and affected persons and businesses in the area, feedback

Following consultation from the public and affected persons and businesses in the area, feedback received on the request for a business use of road permit, to enable closure of one car park on Tasman Terrace, in order to construct an outdoor dining area adjacent to 80-81 Tasman Terrace has raised some related pedestrian safety concerns.

For this reason, it is recommended that the proposal cannot be supported at this time, without additional work to address these pedestrian safety concerns. To do so, is recommended that Council undertake a further technical assessment, including traffic and pedestrian counts, of the pedestrian safety concerns raised so that Council can be informed as to;

- 1) Whether a warrant exists for a formal pedestrian crossing on Tasman Terrace in the vicinity of Adelaide Place and Bligh Street;
- 2) The preferred location for such a crossing; and
- 3) Whether the outdoor dining proposal at 80-81 Tasman Terrace or any future similar proposals at other locations would have an impact on a future pedestrian crossing.

The officers recommendation has been drafted to account for these concerns and allow for consideration of a budget in the next financial year 2025/26 to progress.

# **Project Overview**



The effect of a pedestrian crossing will be two fold:

- 1/ Slow current excessive vehicular speeds, thus enhancing pedestrian safety.
- 2/ Enhance the "relaxed tourism lifestyle" of our beautiful seafront lawns.

The pedestrian crossing should be similar to the existing crossing leading to the Town Jetty; but should be reduced in width to perhaps half of the excessive Town Jetty width.

I suspect a crossing of 2.5, perhaps 3 metres width, would be ample.
