9. DEPUTATIONS/REPRESENTATIONS**9.1 MS TIJANA STOCKHAM – LAND REVOCATION PROPOSAL FOR HARBOURVIEW RESERVE**

Councillor Broadfoot declared a **Material** conflict of interest pursuant to Section 75 of the Local Government Act 1999 in **Agenda Item 9.1 Deputation – Ms Tijana Stockham – Land Revocation Proposal for Harbourview Reserve** and advised she would leave the meeting as her son and his fiancé own a property overlooking Harbourview Reserve and has participated in the consultation opposing revocation of community land status.

12.1 REVOCATION OF COMMUNITY LAND STATUS – 10 OSWALD DRIVE – PUBLIC CONSULTATION SUMMARY REPORT
