The City of Port Lincoln has released the Draft Port Lincoln Master Plan and is seeking your feedback.

Consultation on the Draft Master Plan is open from Thursday, 30 October 2025 until Thursday, 27 November 2025.

The Master Plan will guide future development and growth within the Council area over the next 30 years.

Preparation of the Master Plan has been informed by infrastructure and traffic investigations, along with early agency and community consultation.

The Master Plan outlines a series of Actions relating to the following Themes:

- Social and Community Infrastructure;
- Cultural and Built Heritage;
- Tourism:
- Residential;
- Employment and Commercial;
- Infrastructure; and
- Transport.
